- Subscription place**: at the office of your brokers or custodians which are Thailand Securities Depository Co.,Ltd.(TSD) member.  
N.B. The Thai NVDR will not accept subscriptions by mail.
- Required documentation**
  - Subscription form, duly filled out and signed.
  - Subscription certificate, to be submitted together with :
    - For a subscription of the same amount as allocated, no filling is necessary.
    - For a subscription of more or less than existing rights, state the total units in the respective column.

#### 4. Payment

- **Subscription for full entitlement or less than or excess than the entitlement**, please make payment by money transfer on March 25, 2026 - March 30, 2026 before 12:00 hours. which NVDR holders shall made payable to "Account for share subscription of Power Line Engineering Public Company Limited" BANGKOK BANK PUBLIC COMPANY LTD..   - The cashier check must be specified date and deposited no later than March 30, 2026 before 12:00 hours and collectable through clearing house in Bangkok within 1 business day.
5. If NVDR holders fail to exercise their rights or make a payment within the allotted time schedule, or the check or cashier check is not honored, it shall be deemed that such NVDR holders do not wish to exercise their subscription rights. Thai NVDR shall thus regard the subscription as being void.
6. Refund for unallotted NVDRs
